3. If you arrive late to Melbourne Fashion Week, you may not be admitted until a suitable break in the event and/or may have to forfeit the predetermined seat location.
4. The Promotion commences on the Start Date and ends on the End Date ("Promotional Period"). Entries are deemed to be received at the time of receipt by the Promoter and not at the time of transmission or deposit by the entrant. Records of the Promoter and its agencies are final and conclusive as to the time of receipt.
5. Valid and eligible entries will be accepted during the Promotional Period.

22. The Promoter reserves the right, at any time, to validate and check the authenticity of entries and entrant's details (including an entrant's identity, age and place of residence).
